

# Delmar Brown, maste

In the arcane world of fly fishermen, Delmar E. Brown was Barry Bonds, Cal Ripken Jr. and Ted Williams all rolled into one.

Mr. Brown, 84, of Watsonville, Calif., practically invented the sport of flyfishing for permit fish. He caught more permit - by a factor of five — than any other angler in history, caught the biggest fish using the lightest test line and designed the most popular fly to lure the elusive critters.

Mr. Brown, who died Wednesday, was best known for having caught 513 of the round, disk-shaped permit fish. The next closest angler has caught somewhere around 100.

He was a practitioner of the sport of fly-fishing, in which an angler tosses a fragile line and fuzzy lure far away into the water in hopes

of landing a fighting fish. About 20 years ago he caught the bug for permit fishing, one of the world's most difficult fishes to catch in shallow water, where it is often found around the Carib-

The fish has exceptional eyesight and can spot a fisherman and poorly made lure a mile away.

Baseball Hall of Fame slugger Ted Williams, a fisherman himself, once told a friend about attempting to catch permit: "Forget it. A complete waste of time! Christ couldn't catch those . . . on his best dav.'

Mr. Brown, however, was an innovator. He played around with a crab fly, adding weight to it so that it would sink when cast and look to a permit like a real crab diving to the bottom.

The permit went for it, and Mr. Brown was on his way to the record books.

## **NEW JERSEY** Support Fowler, 95, sea survivor

Elizabeth Fowler, 95, of West Orange, N.J., who wrote a harrowing book about being the only woman among 35 passengers on a lifeboat in the Atlantic Ocean for 10 days during World War II, died May 30.

On an autumn evening in 1942, she was in her early 30s and had finagled passage on a cargo ship from Africa to escape a troubled marriage and join her daughter in Connecticut. A German U-boat torpedoed the ship.

She endured pounding rain, hunger, excruciating thirst, frigid waves and circling sharks as she and her companions bobbed through an intense human drama. Critics acclaimed her book, "Standing Room Only."

# Carpenter, active artist

A half-finished still life of radishes, lettuce and green onions sits on an easel, left behind when Gilbert Frederick "Bert" Carpenter of Greensboro, N.C., died Friday

He had a life full of art collecting it for the Weatherspoon Art Gallery, teaching it and doing it, nearly every day, no matter what else was going on in his life.

His work has been exhibited nationally since the 1950s.

"If you're not painting, you're not an artist," he said in a 1999 interview. "It's a real crapshoot, and once you become aware of that . . . it makes it so you can't sleep at night unless you've gotten your painting done.

He said the controversy over the Dade County law "created a chaotic, divisive, restless, emotional atmosphere in our community."

Miami-Dade County has since passed and upheld a gay rights ordinance.

During his nearly 50 years in the legal system, the judge was known for the kneelength, colorful "minirobes" he wore while presiding.

The court ruled Juanita Hayes, 27, was denied a fair trial in October 1986 occause a Guilford County judge did not instruct jurors to consider acquitting her on the grounds of colf defense. Hayes maintained that she drew self-defense. Hayes maintained that she drew a knife to protect herself against Keith Brown, who had struck her and pushed her to

the ground several times.

Brown, 17, died of a single knife wound that pierced his heart and liver Sept. 10, 1985.

The fight between Hayes and Brown broke out in the parking lot of Parkside Apartments on O'Conner Street, where several men had gathered to drink. They argued, and Brown hit her and pushed her down.

What happened after that is a subject of

Beirut, Lebanon — Lebanese authorities were investigating Friday whether the slaying of an American missionary was linked to anti-U.S. sentiment in the Middle East, but a Palestinian guerrilla official said the killing was to avenge her Christian evangelist activity in a Muslim town.

The U.S. Embassy, however, said it was too early to speculate on the motive behind the first targeted killing of an American in Lebanon in more than a decade.

Bonnie Penner, 31, a nurse at a missionary clinic caring for the needy Lebanese and Palestinians, was shot to death Thursday in the southern port city of Sidon.

Investigators believe a gunman knocked at the door of the clinic and shot Penner with a 7 mm pistol. Her body was found lying in a pool of blood with three gunshot wounds to the head.

"I would not think that this is our calling to say bad things about this religion," said the Rev. Pierre Francis, the pastor of Mieh Mieh Baptist Church, where Witherall and her British husband, Garry, were members. "They just jeopardize our safety."

Witherall, who grew up in Vancouver, Wash., came to Lebanon nearly two years ago with her husband. The two met while studying at Moody Bible Institute in Chicago in the mid-1990s before joining Operation Mobilization, a missionary organization that sends Christian evangelists around the world, Francis said. They had been married four years and had no children, he said.

Operation Mobilization's U.S. headquarters are in Tyrone, 23 miles south of downtown Atlanta. Witherall visited the headquarters in 1999 for a five-day orientation session, said Rick Hicks, president of the organization.

"Obviously, it's a tragic situation," Hicks said. "As a young woman of 31, it's overwhelming."

He said people in the Fayette County office remembered Witherall's interview sessions, conducted to determine whether she was an ideal candidate for Operation Mobilization.

The agency sends out roughly 3,000 Christian missionaries to 85 nations in the world. But Hicks said the Georgia office does not oversee missions abroad and that each country's missions are semi-autonomous.

Friends described Witherall as an outgoing brunette who used to accompany women from the poor areas of Sidon, 40 miles south of Beirut, or the nearby Palestinian refugee camp of Ein el-Hilweh on their deliveries.

Witherall was shot three times in the head at close range with a 7 mm pistol, the police said, and collapsed in a pool of blood inside the door of the two-story building that housed both the clinic and an evangelical church.
